HHA's Director of Real Estate Development consulted with the RAB on October 24, 2019 and on November 21, 2019. A copy of the Agenda is attached.

Ms. Quisha Riche attended the October 24, 2019 RAB meeting. She explained that he met with property managers for each site to collect information to prioritize capital fund projects. She also shared the current Five Year Action Plan and passed out comment forms. On November 21, 2019, Ms. Riche attended the RAB meeting and received written comments during the meeting. The comments are detailed in the analysis portion below. The RAB was also invited to attend the December 11, 2019, Five Year/Annual Plan/Five Year Action Plan public hearing at 4:30 p.m. at the Oscar Mason Center.

Analysis of Written Comments from RAB Board

Many of the comments were operating fund eligible items so RAB members were told to present them to their property managers directly. Elevator upgrades at Johnson Towers are currently in our year 2019 budget. Toilets and shower surrounds for Brookside have been included in year 2021 of our 5YAP. Dryer connections have been requested at Lincoln Park. We continue to work internally to determine how to best address this need as there is not adequate space in the units to accommodate dryers. Handicap accessible doors at Johnson Towers are in year 2020 of our 5YAP.
